## **Application Process and Visa Information**

All international students studying in the USA must have an F-1 Student Visa. Transworld Schools is authorized by Federal Law to issue a Certificate of Eligibility for the I-20 Form for the F-1 Student Visa. Transworld provides a personal admissions service for all students. If you have any specific visa or travel related questions or concerns [please email us](#).

If you wish to transfer into Transworld from another program, please contact us for a Transfer Form. If you wish to change your status to F-1, we can assist you with filing the application.

### **Where to Start**

1. Submit a completed Transworld Application Form for ESL
2. Pay the application fee and course tuition
3. Provide evidence that you have sufficient funds to cover your full course of study plus living expenses while enrolled in your Transworld program (Tuition plus living costs of a minimum of \$1000 for each month of study)
4. Submit your High School Diploma, University Degree, or English Language School Certificate or transcript.

### **Qualifying for a Student Visa**

Once Transworld has issued you with a Certificate of Eligibility/I-20 form, you will need to make an appointment with the American Embassy or Consulate in your country of residence. Although it is possible to apply for a visa in another country, the visa application process is usually easier in your country of residence. You will need to schedule sufficient time to apply for your visa before leaving your country. All applicants should be prepared to provide pertinent documents such as academic records, financial information and personal background information when being interviewed by the consulate.

### **When You Arrive in the USA**

When you arrive in the USA (at the airport or border), you must show your I-20 Form to the Immigration Officer. Immigration will stamp your I-20 and staple an I-94 form (Arrival-Departure Record) into your passport. You will need to bring these documents to Transworld on your first day. The Admissions Officer will make copies of them for your student file.

Remember, your student visa requires that you study not less than 18 hours per week. This means that you need to maintain good attendance. If you are unable to attend a class for any reason or have any immigration questions, you should inform the Transworld staff.

## **Accommodation**

### **Where will I stay?**

We want you to be safe, comfortable and happy throughout your stay in San Francisco and have the opportunity to meet Americans and other international students. You can choose either host family accommodation or student residence, and all are within walking distance or easily accessible by local transportation. Transworld does not provide dormitory accommodation in a Transworld dormitory.

### **Host Family**

Living with an American host family is the best way to be completely immersed in English language and the local culture. You will enjoy the comforts of a home and build a lasting relationship with your second family. Continental breakfast and dinner is included. Commute time is not more than 45 minutes each way; commute cost is not included.

Host family prices range from \$700 to \$1200 per 4 weeks depending on whether the room is shared or private, with or without food. We will book the host family for you according to your specifications. There is a \$150 host family booking fee.

### **Student Residences**

Transworld recommends residences that cater to international students. Every room in our preferred residences is equipped with a television, phone, desk, free Internet access and maid service. You can choose a shared or private room with shared or private bath. Most residences provide breakfast, and students may have access to the kitchen. Please email us at [info@transworldschools.com](mailto:info@transworldschools.com) for a current list of available accommodation.

Student residence prices range from \$750 (shared room/shared bath) to \$1400 (private room/private bath) (\$1580 private room/private both, 2 meals per day) per 4 weeks. You may book yourself by contacting the Residence directly or we can book for you. If we book for you, there is a \$150 booking fee.

## **Transworld Schools**

All classes are taught on-site at the 551 Sutter location; There are 12 classrooms, a computer lab with 20 stations, a teacher's room, 3 administrative offices, 1 student common room and 2 student lounge areas, 5 bathrooms with 9 toilets. There is no library; however, students may check out textbooks and software using a sign-up sheet.

Online English Program is taught online though live instruction using the zoom conferencing platform. Online students do not need a zoom subscription and their class instructor will email them the zoom link for the class.

## **Transportation**

Transworld Schools is located at 551 Sutter Street between Mason and Powell Streets in downtown San Francisco. Public parking is available on Sutter and on Taylor, close to the school. The BART/MUNI station is at Powell Street. San Francisco International Airport arrivals should take the shuttle from the upper departure level to the hotel.

Evaluation will be based on the following:

- (1) Continual assessment of classwork, weekly throughout the course.
- (2) Grading of written assignments, not less than bi-monthly throughout the course.
- (3) Mid and End of course progress test, not less than once per month.

The minimum requirement for course completion is 80% attendance and a course progress grade of C.

#### **(2) Attendance, Tardiness, Absenteeism, Dismissal and Right to Appeal**

Transworld Schools expects all students to attend not less than 80% of all classes and to arrive at class to start on time. If you are going to be late or absent, you must call the school. Students are required to attend 80% of their classes on the regular ESL schedule and are permitted to make-up missed classes subject to availability.

If you are regularly absent or late, or have more than 2 consecutive absences without a doctor's letter, the School Director will meet with you and assist you in finding a solution. A copy of the meeting and outcome will be placed in your file and you will be put on probation. Each probation period is 4 weeks and if the student fails to improve their attendance to 80% by the end of the 4-week probationary period, they will be issued with a 2<sup>nd</sup> probation notice. A student receiving 3 probation notices in a 3-month period will be dismissed from the program and not be permitted to re-enroll.

Students who are dismissed from the program, have the Right to Appeal. A student receiving a dismissal notice has 10 days to appeal the dismissal from the date of notification. They will meet with the Director, Program Administrator and Course Instructor to discuss the dismissal and provide any documentation such as medical records or proof of extenuating circumstances that may justify their inability to have met the 80% minimum attendance requirement. If the absenteeism/tardiness persists, and if all efforts on the part of the staff and student fail to resolve the situation, Transworld will dismiss the student.

In the case where Transworld finds that the student's situation is justified, the dismissal will be cancelled and the student will be permitted to remain in the program. The Director will



write a report noting the decision and place it in the student's file and give a copy of the report to the student. For the non-F1 IDL programs only, where the student is still experiencing difficulty in meeting the 80% minimum attendance requirement due to a continuation of their extenuating circumstances, Transworld will require them to leave the program without prejudice and apply for re-enrollment when their situation has improved and they are able to meet the program's attendance requirement.

Students are not permitted to be promoted to the next class level while on attendance probation but will be retained at their current level until their attendance has improved to 80% or above, at which point they may be promoted providing their grade is 70% or above. Students completing their program while on attendance probation will receive a 'Fail' on their final transcript.

Dismissed students are refunded in full for the classes they have not taken after their Last Date of Attendance. There are no refunds for classes and hours missed during the program.

An F1 student who is absent from class for 30 days will be assumed to have left the program and will be automatically terminated in SEVIS. F1 and non-F1 IDL students leaving the program early will be refunded for the lessons they have not taken dated from their Last Day of Attendance. They will be marked as 'Incomplete' on their final transcript.

### **(3) Leave of Absence Policy**

You must attend 80% of the course in order to complete. You must request any Leave of Absence (LOA) in writing and sign it. You must include your expected date of return in your written request. You may not take more than 50% of your total course length as a LOA. If you have a student visa, you will not be allowed to take a leave of absence other than for documented emergencies and this will be recorded on your SEVIS record according to SEVIS (student visa) regulations.

There is no Leave of Absence Policy for non-F1 IDL students. Students may withdraw from the program and receive a refund. IDL students may then apply for re-admission.

### **(4) Re-Admission**

Students who are dismissed and are requesting re-admission should discuss their re-entry status with the School Director.

### **(5) Behavior Problems**

Transworld Schools reserves the right to dismiss the student for continuous disruptive behavior. Smoking is not permitted anywhere in the school, or in the building where the school is housed, including the lunch room and restrooms.

### **(6) Sexual Harassment**

If you feel that you are the victim of sexual harassment, you should report any such incident to the School Director or to the staff member of your choice. All reports of sexual harassment received by Transworld Schools will be investigated in a completely confidential manner. Any student or staff member who is found to have sexually harassed other students or staff members will be dismissed.

### **(7) Student Records**

All student records are kept in the administrative offices at Transworld Schools for five years. Transworld

maintains student transcripts and F1 visa I-20's permanently. You may access your student file. All student files are confidential and Transworld Schools is not able to release any information regarding an individual student without that student's written permission.

### **(8) Transfer of Credits**

No credit hours are awarded for ESL courses and Transworld Schools does not accept transfer of credits from other schools or programs for ESL courses. Transworld does not award credit for prior experiential learning. There are no transfer or articulation agreements between Transworld Schools and any other college or university that provides for the transfer of credits earned in the program or instruction.

### **NOTICE CONCERNING TRANSFERABILITY OF CREDITS AND CREDENTIALS EARNED AT OUR INSTITUTION.**

The transferability of credits you earn at Transworld Schools is at the complete discretion of an institution to which you may seek to transfer. Acceptance of the certificate you earn in ESL is also at the complete discretion of the institution to which you may seek to transfer. If the certificate that you earn at this institution is not accepted at the institution to which you seek to transfer, you may be required to repeat some or all of your coursework at that institution. For this reason you should make certain that your attendance at this institution will meet your educational goals. This may include contacting the institution to which you may seek to transfer after attending Transworld Schools to determine if your certificate will transfer.

### **9) Student Tuition Recovery Fund (STRF)**

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program.

It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. To be eligible for STRF, you must be a California resident or are enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of the following:

1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
2. You were enrolled at an institution or a location of the institution within the 120 day period before the closure of the institution, or were enrolled in an educational program within the 120 day period before the program was discontinued.
3. You were enrolled at an institution or at a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.

5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.

To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for the recovery from STRF.

A student whose loan is revived by a loan holder or debt collector after a period of non-collection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than for (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery with the original four (4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a social security number of a taxpayer identification number.

### **STUDENT'S RIGHT TO CANCEL**

## **REFUND POLICY**

### **Refund During Cancellation Period**

A student is allowed to cancel an agreement for a course of instruction and obtain a 100% refund of charges paid (less the non-refundable \$100 application fee), if cancellation is made through attendance at the first class through attendance at the first class session, or the seventh day after enrollment, whichever is later. The student is advised that a notice of cancellation shall be in writing, and that a withdrawal will be effectuated by the student's written notice or by the student's conduct, including but not necessarily limited to, a student's lack of attendance. If mailed in, the cancellation note becomes effective as of the postmark if properly addressed with proper postage.

### **Refund After Cancellation Period**

If a student withdraws after seven (7) business days where the first day is the first day class was attended, the student is entitled to only a partial refund. The student has the right to withdraw from school at any time and receive a refund for that part of the course not taken, for which the student has paid. The amount of that refund is to be "100% pro-rated" which means that the student is refunded for all classes paid for but not taken after the point of last date of attendance (LDA) from the course. The refund is to be paid within thirty (30) days of withdrawal and a refund notice is to be sent to the student.

### **Refund Example**

The following is an example of refunds and amounts. The 4-Week Intensive English Course costs \$460 and meets for 72 clock hours. There is no special equipment for this course. There is an additional \$100 non-refundable charge for materials. There is an additional \$100 non-refundable application fee. If the student has paid for the course in full (\$460) and withdraws after completing 36 hours of instruction, or 50% of the course, the student will receive 50% of the tuition as a refund (\$230).

### **Tuition Payment**

A \$100 non-refundable Application Fee is due 4 weeks prior to the course start date (later when applications are accepted less than a month prior to course start date). The tuition is due in full on the first day of the course, or in payments every 4 weeks, due on week 1 of the 4 week payment period. Failure to pay tuition on the first day of the class on week 1 of the payment period will result in exclusion from the class until tuition is paid. Transworld Schools treats all students fairly and equitably relative to tuition, other charges, and refunds.

### **Student Complaint Procedure**
